Expressions of Interest

The Government of Guyana has received a loan from the Inter-American Development Bank (IDB) toward the cost of Georgetown Water Supply and Sewerage Programme II, and it intends to apply part of the loan proceeds to payments under the contract for Shelter Belt Water Treatment Plant Rehabilitation.

Guyana Water Incorporated now invites sealed bids from eligible and qualified bidders for the Procurement of one 1250 KVA generator. The supply period will be 180 days after the award of the contract.

Bidding will be conducted through the international competitive bidding procedures specified in the IDB's *Policies for the Procurement of Works and Goods*, and is open to all bidders from eligible source countries as defined in the policies.

Interested eligible bidders may obtain further information from, inspect and acquire the bidding documents at the Customer Relations and Commercial Services Office, Guyana Water Incorporated, between 0800 and 1630 hours, Monday through Thursday, and between 0800 and 1530 hours on Fridays. The Guyana Water Inc. officers in charge are Mrs. Kevin Horn and Ronald Rajnarine. They may be contacted by phone or fax listed below.

Qualifications requirements include: suppliers with five years and over, technical, financial and legal experience in supplies of this nature. A margin of preference for eligible national contractors shall not be applied. Additional details are provided in the bidding documents.

A complete set of bidding documents, in English, may be purchased by interested bidders on the submission of a written application to the first address below and upon payment of a non-refundable fee of 5,000.00 GYD or US\$ 25. Bidding documents may also be downloaded from the company's Web site below. The method of payment will be by certified check to Guyana Water Incorporated for hard copies. However, the documents sent by e-mail will be free of charge.

All bids must be accompanied by a bid security or bid-securing declaration, as appropriate, of no less than US\$ 5,000 or an equivalent amount in Guyana Dollars and be delivered to the Secretary, National Procurement and Tender Administration Board, at the second address below, at or before 0900 hours on 23 May 2006. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened immediately thereafter, in the presence of the bidders' representatives who choose to attend, at the office of the Secretary (same address).

Bidders registered in Guyana must submit an IRD Compliance indicating that they have met their Income Tax obligations and an NIS Compliance indicating that they have met their NIS obligations.
