## Supply of Digital Dial Radio Sets

1. The *Cooperative Republic of Guyana* has received a loan from the Inter-American Development Bank toward the cost of **Support to Safety Nets for Vulnerable Populations Affected by Coronavirus in Guyana (Component 2)**, and it intends to apply part of the proceeds of this loan to payments under the Contract for the **Supply of Digital Dial Radio Sets**.

2. The ***Ministry of Education*** invites sealed offers from eligible Suppliers for the **Supply of Digital Dial Radio Sets**. The RFB will be conducted through the International Competitive Bidding (ICB) procedures specified paragraphs 2.1 - 2.85 of the Inter-American Development Bank's Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN-2349-15 approved by the Board of Executive Directors of the Bank on 2nd of August 2019 and effective 1st of January 2020 and is open to all bidders from Eligible Countries as defined in the bidding document.
3. Interested bidders may obtain further information from ***Ministry of Education-Project Implementation Unit, Project Coordinator*** at the ***address 1*** given below from ***8:30 hrs. to 16:30 hrs. from Mondays to Fridays***.
4. Qualifications requirements include: The Bidder shall furnish documentary evidence to demonstrate that it meets the following requirement: (a) Furnish documentary evidence by providing copies of contracts, award letters, invoices or similar to demonstrate that they are a supplier of equipment and electronics within the past three years with a minimum average value of Ten Million Guyana Dollars
5. A complete set of the bidding documents in *English* may be obtained by interested bidders on the submission of a written Application to the address (1) below from Monday, December 05, 2022. Bidders are required to indicate an e-mail address in their application, where the bidding package and any changes to the bidding document can be sent and received by bidders.
6. Bids must be delivered to Address 2 below at or before ***Tuesday, January 17, 2023, at 09:00hrs.*** Electronic bidding *shall not* be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person or on-line at the Address 2 below at ***Tuesday, January 17, 2023 at 10:00a.m est.***
7. Bids *shall* be accompanied by a completed and signed Bid Securing Declaration Form as required in Section 19.1 of the Bid Data Sheet.
