RESOLUTION DE-143/14

Brazil. Loan 3309/CH-BR to Brazilian Securities Companhia de Securitização
China Co-Financing Fund for Latin America and the Caribbean

The Board of Executive Directors

RESOLVES:

1. That the President of the Bank, or such representative as he shall designate, is authorized in the name and on behalf of the Bank, as administrator of the China Co-Financing Fund for Latin America and the Caribbean (the “Fund”), to enter into such agreements as may be necessary with Brazilian Securities Companhia de Securitização, a mortgage securitization firm incorporated and organized under the laws of Brazil, to grant it financing to fund the acquisition and accumulation of eligible residential and commercial mortgage instruments and real estate credits in Brazil, and their further domestic capital markets placement. The financing will consist of a loan for the amount of up to US\$25,000,000 from the resources of the Fund, administered by the Bank. The financing will be subject to the terms and conditions indicated in the Executive Summary of the Loan proposal contained in document PR-4207.

2. That the above-mentioned loan is to be provided in connection with the Brazilian Securities Mortgage Securitization Partnership in addition to the A loan for the amount of up to US\$50,000,000 to be provided from the Ordinary Capital resources of the Bank pursuant to Resolution DE-142/14.
