RESOLUTION DE-11/12

Regional. Loan 2702A/OC-RG to Banco Itaú BBA S.A.

The Board of Executive Directors

RESOLVES:

That the President of the Bank, or such representative as he shall designate, is authorized in the name and on behalf of the Bank, to enter into such agreements as may be necessary with Banco Itaú BBA S.A., a *sociedade anônima* incorporated and organized under the laws of Brazil, acting through its branch in Nassau, Bahamas, to grant it financing for projects supporting energy efficiency, renewable energy, cleaner production and carbon credit generation in Brazil, Chile, Colombia, Paraguay, Peru and Uruguay. The financing will consist of an A loan for the amount of up to US\$100 million from the Ordinary Capital resources of the Bank, and may include a B loan for additional resources to be contributed by commercial banks or other financial institutions through the subscription of participation agreements with the Bank (the “B Loan”). The financing will be subject to the terms and conditions indicated in the Executive Summary of the Loan Proposal contained in document PR-3843. The President of the Bank, or such representative as he shall designate, is also authorized to subscribe the participation agreements with the commercial banks or financial institutions participating in the B Loan and to execute any other agreements as may be necessary with other parties to complete this transaction.
