The Ministry of National Security *has received* financing in the amount equivalent to US \$20 million from *the Inter-American Development Bank (IDB)*, and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under the project Security Strengthening Project (SSP). *Bidding will be governed by the Inter-American Development Bank's eligibility rules and procedures.*

The Government of Jamaica through the Ministry of National Security (MNS) is implementing the Security Strengthening Project (SSP) which is comprised of the following three (3) components:

- (i) Violent crime prevention and management;
- (ii) Improving investigative capabilities for homicides and;
- (iii) Change Management and Communications.

The Security Strengthening Project is aligned with the Sector Strategy on Institutions for Growth and Social welfare (GN-2587-2 and the Sector Framework for Citizen Security and Justice (OP-1201). The project is consistent with the 2016-2021 IDBG Country Strategy with Jamaica (GN-2868) and will contribute to the Corporate Results Framework (CRF) 2016-2019 (GN-2727-6) output indicators of: (i) Government agencies benefited by projects that strengthen technological and managerial tools to improve public service delivery; and (ii) Crime information systems strengthened. The project is also aligned with the 2017 Jamaica's Ministry of National Security Five Pillar Strategy for Crime Prevention and Citizen Security.

The goods and services to be procured under this Project include: *Office Furniture and Equipment; Stationery and Office Supplies; Consultancy and Non-Consultancy Services; ICT Infrastructure, Software and Equipment; Hand Held Devices & Surveillance Equipment; and other goods and services.*

Procurement processes of contracts financed by the Inter-American Development Bank will be conducted in accordance with the [*Policies for Procurement of Goods and Works financed by the Inter-American Development Bank*](#)GN-2349-9, and is open to all eligible bidders as defined in the policies.[*For these procurement processes domestic preference shall be applied to compare bids.*ⁱ]Consulting services will be selected and contracted in accordance with the [*Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank*](#)GN-2350-9.

Specific procurement notices for contracts to be bid under the Inter-American Development Bank's international competitive bidding (ICB) procedures, will be published as they become available. For consulting services expected to cost an amount equivalent to US \$200,000 or more, a request for expressions of interest contracts will be advertised in [*UN Development Business*](#)ⁱⁱ and [*Inter-American Development Bank's*](#) Web Site the gleaner and Daily Observer.
