

AMENDATORY CONTRACT NO. 1

AMENDATORY CONTRACT entered into between JAMAICA (the "Borrower") and the INTER-AMERICAN DEVELOPMENT BANK (the "Bank", and together with the Borrower, the "Parties").

ARTICLE ONE

The Parties agree to amend Loan Contract No. 4374/OC-JA (Support to the Public Sector Transformation Programme (Investment Component)), entered into between the Borrower and the Bank on February 21, 2018 (the "Loan Contract"), in the manner and to the extent set forth below.

1. Section 4.01 "Executing Agency" of the Special Conditions is amended in its entirety to read as follows:

"SECTION 4.01. Executing Agency. The Ministry of Finance and the Public Service, acting on behalf of the Borrower, shall be the Executing Agency for the Programme."

2. Sub-section (a) of Section 6.02 "Communications and Notices" of the Special Conditions is amended in its entirety to read as follows:

"SECTION 6.02. Communications and Notices. (a) Any notice, request, communication, or report from one Party to another by virtue of this Contract related to the execution of the Programme, with the exception of the notices indicated in paragraph (b) hereof, shall be made in writing and shall be considered to have been made when the relevant document is delivered to the addressee at the respective address given below, or by electronic means under such terms and conditions as the Bank establishes and communicates to the Borrower, unless the Parties agree otherwise.

3. Paragraph 4.01 of the Annex is amended in its entirety to read as follows:

"4.01 The Ministry of Finance and the Public Service will be the Executing Agency (EA) of the Programme."

ARTICLE TWO

The Parties hereby ratify that all other provisions of Loan Contract No. 4374/OC-JA, remain in full force and effect.


ARTICLE THREE
