2. As Partes acordam que todas as referências à Secretaria Municipal de Projetos Especiais - SEMPE, previstas no Contrato passarão a ser entendidas como referências à “Secretaria Municipal de Inovação, Sustentabilidade e Projetos Especiais – SEMISPE”.





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
