

**AMENDMENT No. 1**

**to the**

**ADMINISTRATION AGREEMENT**

**represented by the Swiss Agency for Development and Cooperation**

**regarding**

**Project Specific Grant to the Inter-American Development Bank for  
Project HO-L1063/HO-G1244, titled “Program of Support for the  
Implementation of the Comprehensive Civic Coexistence and Public  
Safety Policy”**

**THIS AMENDMENT No. 1** is entered into between the Inter-American Development Bank (the "Bank") and the Government of Switzerland, represented by the Swiss Agency for Development and Cooperation (the "Donor", and together with the Bank, the "Parties").

**WHEREAS**, on May 16, 2016, the Parties entered into a Project Specific Grant (PSG) Administration Agreement (the "Administration Agreement") in connection with the Bank's Project No. HO-L1063/HO-G1244 titled, "Program of Support for the Implementation of the Comprehensive Civic Coexistence and Public Safety Policy" (the "Project"), as further described in the Project Document attached to the Administration Agreement (the "Project Document"); and

**WHEREAS**, the Parties desire to modify the Contribution payment schedule in and the expiration of the Administration Agreement, and to update the Project budget in the Project Document.

**NOW, THEREFORE**, the Parties hereby agree to amend the Administration Agreement in accordance with Section 19 thereof and to update the information in the Project Document as follows (throughout this Amendment No. 1, capitalized terms used but not defined herein shall have the meanings ascribed to them under the Administration Agreement):

1. The payment schedule in Section 3 of the Administration Agreement is hereby deleted, and shall be replaced with the following:


<u>"Date:</u>	<u>Amount:</u>
No later than June 30, 2016	US\$1,500,000 (one million five hundred thousand Dollars)
No later than December 31, 2017	US\$2,700,000 (two million seven hundred thousand Dollars)
No later than September 30, 2018	US\$1,200,000 (one million two hundred thousand Dollars)"

2. The date "March 18, 2018" in Section 18 is hereby deleted, and shall be replaced with "December 31, 2018".
3. The Project budget in Table I of the Project Document is updated with the budget included in Annex I attached hereto.
4. All other terms and provisions of the Administration Agreement not expressly modified pursuant to this Amendment No. 1 shall remain in full force and effect. Further, this Amendment No. 1 shall enter into force on the latest date of its signature below by the Parties, and shall constitute an amendment to, and form an integral part of, the Administration Agreement.

5. Subject to their respective policies and procedures with respect to the disclosure of information, the Parties may make this Amendment No. 1 publicly available.

**IN WITNESS WHEREOF**, the Inter-American Development Bank and the Government of Switzerland, represented by the Swiss Agency for Development and Cooperation, each acting through its duly authorized representative, have signed this Amendment No. 1 in the English language as of the dates indicated below.


