This Invitation for Bids (IFB) follows the General Procurement Notice for this Project that appeared in <I>Development Business</I>, issue no. 729 of 30 June 2008.

The Cooperative Republic of Guyana has received financing from the Inter-American Development Bank towards the cost of the Agricultural Export Diversification Program and intends to apply part of the financing of this loan to payments under the contracts for the supply, delivery, installation and testing of computers, laptops, printers and accessories.

The Ministry of Agriculture now invites sealed bids from eligible and qualified bidders for the supply, delivery, installation and testing of computers, laptops, printers and accessories as follows:

- \*ADP/07/2010 Lot 1 – Supply, Delivery, Installation and Testing of Computers and Accessories
- \*ADP/07/2010 Lot 2 – Supply, Delivery, Installation and Testing of Laptops
- \*ADP/07/2010 Lot 3 – Supply, Delivery, Installation and Testing of Printers

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Inter-American Development Bank's Policies for the Procurement of Works and Goods financed by the Inter-American Development Bank, and is open to all bidders from Eligible Source Countries as defined in the Policies.

Interested eligible bidders may obtain further information from the Director, Agriculture Sector Development Unit [ASDU], Ministry of Agriculture at the address below and at this address from 8:30 am to 16:00 hours on Mondays to Thursdays and from 8:30 am to 15:00 hours on Fridays.

Qualification requirements include:

- \*Bid must be accompanied by a bid security of two percent of the Bid price made out in the name of the Permanent Secretary Ministry of Agriculture, in Guyana dollars or its equivalent in a freely convertible currency
- \*Valid income tax Compliance Certificate (for locally registered firms only)
- \*Valid National Insurance Scheme Compliance Certificate (for locally registered firms only)
- \*Documentary evidence as to the Bidder's qualification to perform

A margin of preference for eligible national contractors will not be applied

Additional details are provided in the Bidding Documents.

Upon request, a prospective bidder may obtain for a non-refundable fee of G\$1,000 (in PDF), the entire Bidding Documents in English on a CD at our office or for foreign firms free of cost via e-mail. Commencement date for the purchase/acquisition of Bidding Documents is 19 July 2010.

Bids must be delivered to the address below before 9:00 hours on 24 August 2010. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address given below at 9:00 hours on 24 August 2010.
