The Government of Jamaica (GoJ) has received full financing from the Inter-America Development Bank (IDB), for the Transportation Infrastructure Rehabilitation Programme. The programme of works will be executed by the National Works Agency (NWA), an Executive Agency of the Government of Jamaica.

The Ministry of Transport and Works (MTW)/National Works Agency (NWA) invites eligible contractors to submit pre-qualification applications and tenders for Dry River Bunding Works under the Transportation Infrastructure Rehabilitation Programme.

The proposed works involve the construction of 1040 meters of Normal Face Bund to protect the river embankment.

Pre-qualification is a pre-requisite for tender eligibility. Local Contractors must be registered with the National Contracts Commission (NCC) in Grade 1 “Civil Engineering Works” Category and have a valid Tax Compliance Certificate (TCC) at the time the documents are submitted.

International Contractors must be from a member country of the IDB. International contractors will be required to be registered with the National Contracts Commission (NCC) in Grade 1 “Civil Engineering Works” Category and have a valid Tax Compliance Certificate (TCC) before award if successful.

Pre-qualification and Tender Documents (in English) will be available as of Wednesday, 23 February 2011 from the Project Manager at the address given below.

A non-refundable fee of Jamaican Dollars J\$3,000 in cash or Manager’s cheque payable to the Chief Executive Officer - National Works Agency is required for both pre-qualification and tender documents.

Tender Security: Tender Security valued at J\$500,000.00 in the form of a Tender Bond or a Manager’s Cheque made payable to “The Chief Executive Officer, National Works Agency” must accompany the tender.

Return of Documents: Completed Pre-qualification Documents are to be placed in a sealed envelope marked “ENVELOPE A – PRE-QUALIFICATION DOCUMENTS FOR THE

Completed Tender Documents are to be placed in a sealed envelope marked “ENVELOPE B –

REHABILITATION PROGRAMME - IDB LOAN 2026/OC-JA – DRY RIVER BUNDING  
WORKS.”

Envelopes A and B are to be placed in a sealed package marked “PRE-QUALIFICATION AND  
TENDER DOCUMENTS FOR THE TRANSPORTATION INFRASTRUCTURE  
REHABILITATION PROGRAMME - IDB LOAN 2026/OC-JA – DRY RIVER BUNDING  
WORKS.”

Pre-qualification Documents not accompanied by a valid Tax Compliance Certificate (TCC) and  
National Contracts Commission (NCC) certificate of registration Grade 1 “Civil Engineering  
Works” Category will be rejected. Tender Documents not accompanied by a Tender Security  
will be rejected. Documents are to be placed in the box marked “PRE-QUALIFICATION AND  
TENDER DOCUMENTS FOR THE TRANSPORTATION INFRASTRUCTURE  
REHABILITATION PROGRAMME - IDB LOAN 2026/OC-JA – DRY RIVER BUNDING  
WORKS” located in the lobby of the National Works Agency at the address below.

Opening of Pre-qualification Documents: Pre-qualification documents will be opened publicly at 11:15 hours on Monday, 28 March 2011 in the Main Conference Room at the National Works Agency.

Pre-qualified Contractors will be invited to a public opening of Tender Documents after the evaluation of the pre-qualification exercise. Only Tender Documents of the pre-qualified contractors will be opened. Tender Documents of Contractors that were not pre-qualified will be returned unopened.
