**RULES OF THE AWARD “JUSCELINO KUBITSCHKEK AWARD OF MERIT FOR REGIONAL  
DEVELOPMENT IN LATIN AMERICA AND THE CARIBBEAN”**

**Article 1**

Candidates for the “Juscelino Kubitschek” Award (the “Award”) may be nominated by any individual and, in particular, by academic institutions and cultural and research centers.

**Article 2**

Nominations shall be presented in writing and shall include a detailed description of the merits and regional importance of the work or contribution. Nominations may be accompanied by any documents providing relevant data and additional information on the candidate. Nominations that do not meet these essential requirements will not be considered.

**Article 3**

The nomination proposals should be delivered electronically to PremioJK@iadb.org.

The deadline for presentation of nominations, with the exception of nominations by members of the Award Selection Committees, **is June 29, 2015.**

Members of the different Award Selection Committees may present nominations after this date, provided they do so at least two days prior to the induction of the respective Committee.

**Article 4**

Nominations that fail to meet the abovementioned requisites shall not be accepted.

None of the documentation presented in support of the nominations will be returned, and no records or correspondence on the documentation will be kept.

**Article 5**

A separate Committee shall be convened for each individual award, and Committee members shall be appointed by the Bank.

**Article 6**

The Award will be granted to the candidate that receives a majority of votes from the members of the Committee. In the case of a tie, the Chairperson of the Award Selection Committee will have the casting vote.

Votes may be cast by persons present at the deliberations that precede the corresponding vote as well as virtually sending a message to PremioKubitschek@iadb.org.

**Article 7**

The “Juscelino Kubitschek” Award shall consist of a diploma and a check in the amount of one hundred thousand U.S. dollars (US\$100,000). In the case of an award shared by several institutions, the amount of the award will be distributed proportionately among them.

In order to receive the diploma and monetary recognition, the winner or winners of the Award shall attend the formal award ceremony. If requested by the Bank, all award winners shall participate in award ceremony events.

**Article 8**

The Bank is authorized to set and adjust the dates and deadlines on the basis of the launch and the process for each edition of the award.
