This invitation for bids follows the general procurement notice for this project that appeared in *Development Business*.

The government of Honduras has received a loan from the Interamerican Development Bank to finance the cost of the Project Reduction of the Poverty and Local Development, Phase II in the the Secretary of State in the office of Government and Justice and it intends to apply part of the proceeds of this loan to payments under the contract of acquisition of computer equipment for the system of administration integrated (SAMI).

The Secretary of State in the office of Government and Justice, across the Technical Unit of Decentralization (UTD), invites sealed from eligible and qualified bidders for the acquisitions of computer equipment for the system of administration integrated (SAMI). The delivery time is 40 days counted from the signing of the contract. The bidders will be able to present offers for a lot, all the lots or any combination of lots.

Interested eligible bidders may obtain further information from the acquisition of computer equipment for the system of administration integrated (SAMI) and inspect the bidding documents at the address given below. Qualifications requirements include: To have been an executor as principal supplier at least of three contracts of magnitude and similar nature, to rely on the signing of the contract a center of service authorized or certified by the manufacturer and to demonstrate that the average balances of his bank accounts during the last six months, his line of in force credit you equalize 100 percent of the offered amount. Additional details are provided in the bidding documents.

Bids must be delivered to the address below at or before 18 August 2009, 10:00 hours, Honduras Local Time (-6 GMT). Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives at the address below at 19 August 2009, 10:15 hours, Honduras Local Time (-6 GMT). All bids must be accompanied by a certified check, letter of credit or a bank guarantee from a banking institution for a two percent of the total amount of the bid in United States Dollars.
