RESOLUTION DE-45/22

Argentina. Conditional Credit Line for Investment Projects (CCLIP) Investments to Promote the Decarbonization of the Energy Sector in Argentina (AR-O0020)

The Board of Executive Directors

RESOLVES:

1. To authorize the President of the Bank, or such representative as he shall designate, to enter into such agreement or agreements as may be necessary with the Argentine Republic, to establish the Conditional Credit Line for Investment Projects (CCLIP) Investments to Promote the Decarbonization of the Energy Sector in Argentina (AR-O0020) (the “Line”) for an amount of up to US\$1,140,000,000, chargeable to the resources of the Ordinary Capital of the Bank.

2. To establish that the resources allocated to the Line shall be used to finance individual operations under the Line, in accordance with: (a) the objectives and regulations of the Conditional Credit Line for Investment Projects approved by Resolution DE-58/03, as amended by Resolutions DE-10/07, DE-164/07, DE-86/16 and DE-98/19; (b) the provisions set forth in documents GN-2564-3 and GN-2246-13; and (c) the terms and conditions included in the proposal for the corresponding individual operation.
